You accept and agree to the following terms and conditions for Your past, present and future Contributions submitted to the Museum. In return, the Museum shall not use Your Contributions in a way that is contrary to the public benefit or inconsistent with its nonprofit status and bylaws in effect at the time of the Contribution.

1. Definitions

"You" (or "Your") shall mean the individual that is making this Agreement with the Museum.

"Contribution" shall mean the code, documentation or other works of authorship expressly identified in Schedule A, as well as any other work of authorship, including any modifications or additions to an existing work, that is, will be or has been submitted by You to the Museum for inclusion in, or documentation of, any of the products owned or managed by the Museum (the "Work").. For the purposes of this definition, "submitted" means any form of electronic, verbal, or written communication sent to the Museum or its representatives, including but not limited to communication on electronic mailing lists, source code control systems, and issue tracking systems that are managed by, or on behalf of, the Museum for the purpose of discussing and improving the Work, but excluding communication that is conspicuously marked or otherwise designated in writing by You as "Not a Contribution."

2. Assignment of Rights. You hereby assign and grant to the Museum all of your rights, title and interest of any kind in any past, present or future Contribution, including any copyrights under the laws of any nation.

3. **Grant of Patent License.** You hereby grant to the Museum and to recipients of the Work, a perpetual, worldwide, non-exclusive, no-charge, royalty-free, patent license to make, have made, use, offer to sell, sell, import, and otherwise transfer the Work, where such license applies only to those patent claims licensable by Contributor that are necessarily infringed by Contribution(s) alone or by combination of Contribution(s) with the Work to which such Contribution(s) were submitted.

4. You represent that You are legally entitled to grant the rights assigned and licensed in paragraphs 2 and 3 above and that no portion of Your Contribution was created in the scope of Your employment by any other person, firm or entity

5. You represent that all portions of the Your Contribution created or developed for inclusion in your Contribution are Your original creations and that no rights in such Contributions are owned by or have been granted to any other person.

6. You represent that any portions of your Contribution that were created or developed by You or any third party for purposes other than for inclusion in Your Contribution are fully licensed, without charge, for reproduction, preparation of derivative works, public display, public performance, sublicense and distribution by the Museum and all recipients of the Work, in accordance with the terms of version 2.0 of the Educational Community License.

7. You agree to notify the Museum of any facts or circumstances of which you become aware that would make these representations inaccurate in any respect.
